2. **ANY 2018-2019 AHSRA Contestant** may enter and participate in the State Finals Rodeo as long as they have completed the following “Condition of Membership” Requirements:
  - (A) Turned in a minimum of \$300 in ads or sponsorships
  - (B) Paid any outstanding fines or fees
  - (C) Sold a minimum of 4 drawdown tickets
  - (D) Submitted an acceptable grade report (**turned in before date of finals Mandatory meeting**)  
\*Contestants failing to meet any of the above requirements will not be allowed to enter and compete at the 2019 AHSRA State Finals.
3. **STATE FINALS ENTRY FORM;** MUST be turned in or postmarked by May 1<sup>st</sup>, 2019 for entry. No entries will be accepted if postmarked after May 1st, 2019. **Get your forms in on time! NO events will be added after May 1st, 2019. NO faxed or emailed forms will be accepted. NO REFUNDS AND NO EXCEPTIONS.**

**FINAL GRADES ARE DUE AT CHECK IN ON JUNE 6th:** Be sure to read the grade note included with your State Finals application form. **You must have your current (2<sup>nd</sup> Semester) grades to compete at State Finals.** If you get your grades early, you can either mail them, or email to [paulandbrandyfrady@gmail.com](mailto:paulandbrandyfrady@gmail.com). **MINOR'S RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

We, the undersigned, hereby request that the below named minor (minor) be granted permission (1) to enter the restricted area, (2) to participate as a contestant, assistant, official or otherwise in rodeo events, (3) to compete for money, prizes, recognition or reward, (4) to be covered by participants' hospitalization insurance, in applicable, as limited by the master policy (all collectively hereinafter called "permissive entry").

In consideration of "permissive entry" to minor into the restricted area, which is the area from which admission to the general public is restricted, which includes, but is not limited to the rodeo arena, competition area, chutes, pens, adjacent walkways, concessions, and other appurtenances, we the undersigned, on behalf of the minor and for ourselves, or personal representative, heirs, next of kin, spouses and assigns, do hereby:

1. RELEASE, DISCHARGE AND COVENANT NO TO SUE the rodeo committee, stock contractor, rodeo association, sponsors, arena operators or owners, and each of them, their officers, agents and employees (all hereinafter collectively referred to as "releases") from any and all claims and liability arising out of strict liability or ordinary negligence of releases or any other participant which causes the undersigned injury, death, damages or property damage. We, the undersigned, jointly severally, and in common covenant to hold releases harmless and to indemnify releases from any claim, judgment or expenses releases may incur arising out of any of the minor's activities or presence in the restricted area.
2. UNDERSTAND that the minor's entry into the restricted area and/or the participation in rodeo events contains CANGER AND RISK OF INJURY OR DEATH TO MIONR, that conditions of the rodeo arena change from time to time and may become more hazardous, that rodeo animals are dangerous and unpredictable, and that there is INHERENT DANGER in rodeo which we appreciate and voluntarily assume because the minor and we choose to do so. Each of the undersigned has observed events of the type that the minor seeks to participate in. We further understand that the arena surface, access ways or lack thereof, lighting or lack thereof, and weather conditions all change and pose a danger to the minor. We further understand that other contestants and participants pose a danger to the minor's entry into the restricted area and/or participation in any rodeo events.
3. AGREE that this agreement shall apply to any incident, injury, accident or death occurring on the above date and FOR A PERIOD OF ONE (1) YEAR THEREAFTER or until the minor's association membership expires, whichever shall last occur. All subsequent agreements release documents signed by any of the undersigned shall amplify, but shall in no way limit the provision of this document. The provisions of this document may be cancelled by any one of the undersigned by delivering to the above rodeo association written cancellation of this agreement which shall be effective 24 hours after the date said cancellation is actually received by the rodeo association.
4. Releaser or parents or guardians of the undersigned minor AGREE TO INDEMNIFY the Releases and each of them from an loss, ability, damage or costs they may incur due to the presence or participation of the minor in the described activities whether caused by the negligence of the Releases or otherwise.

WE HAVE READ THIS DOCUMENT, WE UNDERSTAND IT IS A RELEASE OF ALL CLAIMS. WE APPRECIATE AND ASSUME ALL RISKS INHERENT IN RODEO.
